A RESOLUTION AMENDING PREVIOUSLY INTRODUCED RESOLUTION 2012-03, A RESOLUTION AMENDING AND FIXING THE SCHEDULE OF SEWER RATES AND CHARGES TO BE COLLECTED BY THE MUNCIE SANITARY DISTRICT FROM THE OWNERS OF PROPERTY SERVED BY THE SEWAGE WORKS OF THE DISTRICT

WHEREAS, The Board of Sanitary Commissioners (the "Board") of the Muncie Sanitary District (the "District") has previously introduced on February 7, 2012 for public hearing and for consideration of passage after public hearing RESOLUTION NO. 2012-03 which fixes a schedule of sewage rates and charges to be collected by the District from the owners of property served by the District; and

WHEREAS, said RESOLUTION 2012-03 at Section 3(g) established certain rates for non-metered residential customers; and

WHEREAS, the Board wishes to amend the language used in Section 3(g) to correct and clarify the definition of the size of the non-metered household to which each stated rate in Section 3(g) is applied.

NOW THEREFORE, BE IT RESOLVED by the Board of the Sanitary Commissioners of the Muncie Sanitary District that:

Section 3(g) of Resolution 2012-03 is amended to read as follows:

The flat rate for non-metered residential customers in whose residence is three or more people will be based on an equivalent of 2,000 cubic feet and shall be per quarter as listed below:

The flat rate for non-metered residential customers in whose residence is one and two people will be based on an equivalent of 1,200 cubic feet and shall be per quarter as listed below:
