RESOLUTION NO. 2026- 01**

**A RESOLUTION AMENDING RESOLUTION NO. 2025-2 TO PROVIDE  
CLARITY TO THE SCHEDULE OF SEWER RATES**

*WHEREAS*, the Board of Sanitary Commissioners, as the governing body of the Muncie Sanitary District (the “District”), has heretofore adopted by prior resolution the Sewer Rates of the District, most recently via Resolution 2025-2 (the "Rate Ordinance"), as amended from time to time; and

*WHEREAS*, the Board of Sanitary Commissioners now desires to clarify how the rates and charges are calculated for non-metered residential customers; and

*WHEREAS*, the Board states that this Resolution does not amend any actual rates or charges to any customer and is solely for the purpose of making the calculation thereof more clear to the general public;

*NOW, THEREFORE, BE IT RESOLVED* by the Board of Sanitary Commissioners of the Muncie Sanitary District, Delaware County, State of Indiana, that:

1. Section 3(d) of the Rate Ordinance is deleted in its entirety and replaced with the following language:

“(d) The flat rate for non-metered residential customers in whose residence is three or more people will be based on an equivalent of using 2,000 cubic feet per quarter (or roughly 666.67 cubic feet per month) at the monthly rate listed below plus the Base Charge:

3 OR MORE PEOPLE	\$59.69	\$69.86	\$76.81	\$84.52

2. Section 3(e) of the Rate Ordinance is deleted in its entirety and replaced with the following language:

“(e) The flat rate for non-metered residential customers in whose residence is one or two people will be based on an equivalent of using 1,200 cubic feet per quarter (or 400 cubic feet per month) at the monthly rate listed below plus the Base Charge:

	PHASE I	PHASE II	PHASE III	PHASE IV
1 OR 2 PEOPLE	\$40.91	\$47.88	\$52.65	\$57.93


3. Except as expressly stated herein, all other provisions of the Rate Ordinance shall not be affected by the adoption of this Resolution.

4. This Resolution shall be in full force and effect upon its adoption.

The foregoing Resolution No. 2026- 01 is hereby approved by the Board of Sanitary Commissioners of the Muncie Sanitary District on this, the 18 day of February, 2026.
